PRIVACY POLICY

This privacy policy ("**Policy**") explains the policy regarding the collection, use, disclosure and transfer of your information by LIC Housing Finance Limited ("**LICHFL**"/"**We**") a company registered under the provisions of erstwhile Companies Act, 1956 with CIN L65922MH1989PLCO52257 and having its registered office at Bombay Life Building, 2nd Floor, 45/47, Veer Nariman Road, Mumbai – 400 001 and having its Corporate Office at 131, Maker Tower-F, Cuffe Parade, Mumbai – 400 005, which is, inter alia, engaged in the business of housing finance and advertisement of real estate properties/projects for sale in India on its portal <u>www.realtyassist.lichousing.com</u> and mobile application named HOMY (hereinafter collectively referred to as "**Website**" which term shall mean and include the <u>www.realtyassist.lichousing.com</u> or the mobile application HOMY or both, as the context may require).

The Policy forms an integral part of LICHFL Terms of Use and other terms on the Website ("**Terms of Use**") and shall be read harmoniously with the Terms of Use. Capitalized terms which have been used here but are undefined shall have the same meaning as attributed to them in the Terms of Use and hence we strongly advise that the User should familiarize himself with the Terms of Use and thereafter access the Website.

The Policy is applicable to any person who accesses or avails the Website of LICHFL for the purpose of transacting, displaying or uploading information or views and also includes a person who participates in accessing/using the Website of LICHFL after completing his/it registration in order to create a User Account or Lister Account. 1. INFORMATION RECEIVED, COLLECTED AND STORED BY LICHFL

1.1 Registration Information

LICHFL may receive and store any information you enter on the Website. 2. INFORMATION AUTOMATICALLY COLLECTED/TRACKED WHILE NAVIGATION

2.1 Cookies

To improve the responsiveness of the Website for you, We may use "cookies", or similar electronic tools to collect information to assign each User a unique, random number as a User Identification (User ID) to understand the User's individual interests using the identified computer or device. Unless you voluntarily identify yourself through registration, We will have no way of knowing who you are, even if We assign a cookie to your computer or device. The only personal information a cookie can contain is the information you supply. A cookie cannot read data off your hard drive or device. Advertisers on the Website may also assign their own cookies to your browser (if you click on their ads etc.), a process that We do not control.

Cookies are small data files that We transfer to your computer. We use "session" cookies to keep you logged in while you use the Website, to better understand how you interact with the Website, and to monitor aggregate usage and web traffic information on the Website. We use "persistent" cookies to recognize you each time you return to the Website. We use this persistent cookie to remember your preferences and, if you create a User Account or Lister Account, to make your experience consistent after you register.

2.2 Opting Out

A User has the option of accepting or declining cookies from the Website by changing the settings of their web browser. The Website automatically accepts cookies, but you can change your settings. 2.3 Log File Information

3. INFORMATION SHARING AND DISCLOSURE

3.1 We restrict access to your Information to employees who We believe reasonably need to know that Information in order to fulfil, provide, operate, develop or improve our Website or Services. LICHEL does not transfer, or share Information about you with another Person or

LICHFL does not transfer, or share Information about you with another Person or non-affiliated companies except:

- a) To provide products or services you have requested; or
- b) With your permission; or

- c) Under the following circumstances:
 - We provide the information to LICHFL's employees, agents, trusted partners who work on behalf of or with LICHFL under confidentiality agreements. These companies may use Information about you to help LICHFL communicate with you about offers on the Website and our marketing partners;

We share your Information such as, but not limited to, name and contact number with employees of LICHFL based on expression of interest regarding properties and home loans who may contact you. By using the Website, you authorize LICHFL to contact you via email or phone on your contact details provided to LICHFL and offer you information

and services. You expressly authorize us to call you irrespective of your registration with National Do Not Call registry.

- viii. We may collect non-personal Information such as browser details, operating system, occupation, language, pin code, unique device identifier, location so that we can better understand customer behaviour and improve our products, services, and advertising.
 - ix. We may collect Information regarding customer activities on various portals and/or websites of LICHFL, whether existing or developed in the future, including but not limited to customer portal, online loan application, public deposit portal, e-auction, Talisma – CRM. This aggregated information is used in research, analysis and to monitor products and various promotional schemes. It may be shared in aggregated, non-personal form with third party to enhance customer experience, products offering or services.

4. CONFIDENTIALITY AND SECURITY

4.1 Please note that no system is full-proof, including ours, and though We endeavour to protect the Information from illegal means, the same cannot be guaranteed by LICHFL and hence by accessing the Website you expressly waive all your claims against LICHFL of any nature in this regard.
